This year, the Oregon Legislature passed Senate Bill 479 requiring the establishment or adoption of a written policy (with very specific policy provisions) to prevent workplace harassment, discrimination and retaliation. This new legislation goes into effect on **January 1, 2020** and you are *required* to have a policy in place that meets the requirements of SB 479 by **January 1, 2020**.
